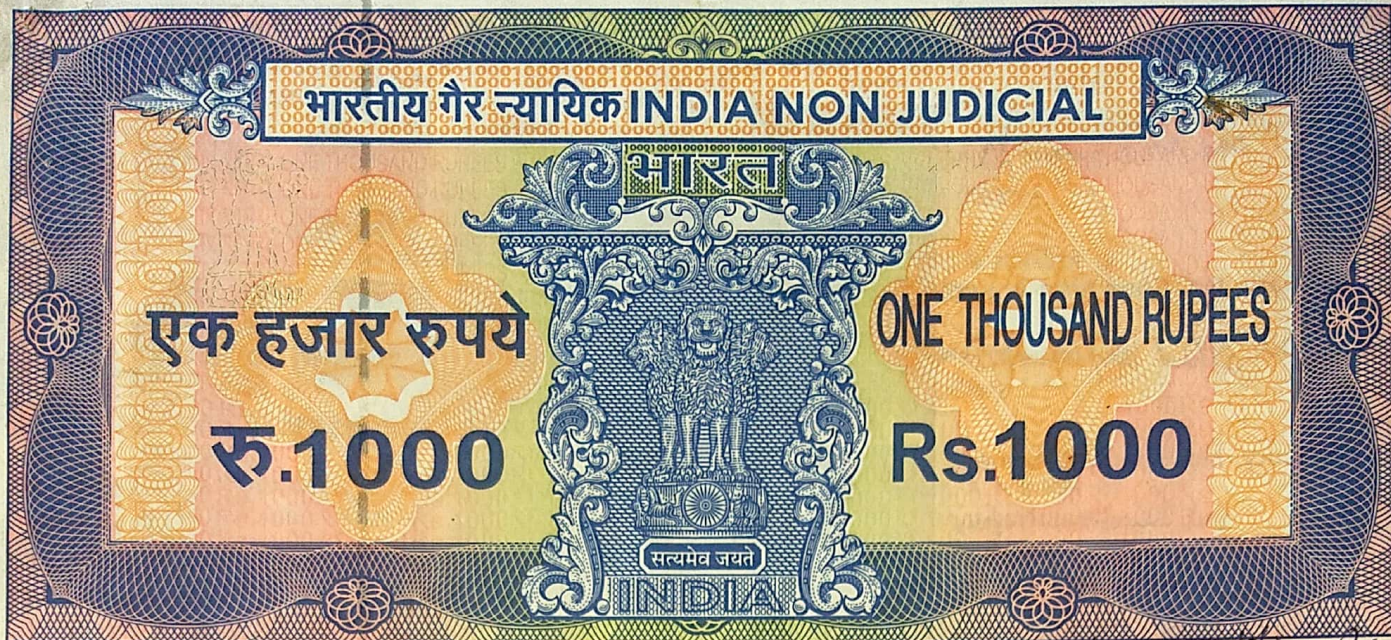



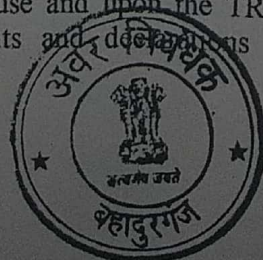

WHEREAS THE SETTLOR.

2. The Trustees have, at the request of the SETTLOR, agreed to act as the FIRST TRUSTEES of the said TRUST and of these presents.
3. The name of the Trust shall be MOHAMMADDIN UNIVERSAL EDUCATIONAL AND WELFARE TRUST
"having Head Office at + P.O Gangi Hat, P.S Bahadurganj, District Kishanganj, (Bihar).
4. Md Shad Arfin Anjum, age 30 years, son of Md Abid Alam, a resident of Satal Nihalbhag, P.O+P.S Bahadurganj, District Kishanganj, (Bihar) shall be the DIRECTER IN CHIFE OF THE TRUST.

5. The SETTLOR has, prior to the execution of these present, transferred the said amount to the Trust, to be hold by the Trustees, on Trusts and subject to the power and other provisions hereinafter contained.

NOW THIS DEED WITTNESSTH that inconsideration of the premises and in order to effectuate the said desire of the SETTLOR and for other good causes to charitable services, to propagate literacy and shall be deemed to have transferred unto the TRUSTEES the said sum of Rs. 1,50,000/- (rupees one lakhs fifty thousand) only TO HAVE TO HOLD the sum (hereinafter mentioned as the TRUST FUND) onto the TRUSTEES to the use and upon the TRUST AND subject to the powers, provisions, agreements and declarations hereinafter declared and contained concerning the same.

6. The expression "TRUST FUND" hereinafter appearing shall mean and shall deem to include the said amount of Rs 2,50,000/- (rupees two lakhs fifty thousand) only as well as all other sums and any property, moveable and immovable that the Trustees may receive from the SETTLOR or any other person or hold, by way of purchase or any other mode of Transfer or grant or by way of profit from Trust Fund and dividend or other investments representing the Trust Fund for the time being and from time to time.

7. The Trustees shall invest the Trust Funds in any of the investments hereinafter mentioned and shall collect or receive dividend and other income accruing on such investment from time to time, and out of such gross income, the Trustees shall deduct the expenses for recovering or receiving such income from the investments.

The object of the Trust shall be:-

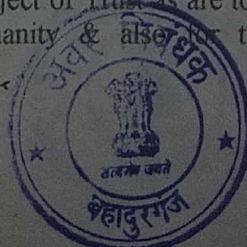
- a) To create a sense of brotherhood, co-operation, mutual harmony, love and affections among the Trustees and other sections of the society.
- b) To perform, work of charity for all sections of the society.
- c) To organize seminar on Social Justice, Educational and Economical upliftment to raise legal demands and Fundamental Rights provided by the Constitution of India.
- d) To open, found, establish, promote, setup, run, maintain, assess, finance, support to all sections of the society & also construct and develop community halls, marriage halls, health centers, libraries, reading room, play grounds, park & other building/institutions for use & for welfare of all communities.
- e) To give, provide and/or render monetary and/or other help and assistance for the relief of persons & animals affected by natural and other calamities such as Flood, Fire, Famine, Earth-quake, Draught & others.
- f) To start, establish, run, takeover or manage & maintain schools, technical & vocational colleges, hospitals and old age homes with the object to provide sound Education as well as proper hospitality services to all sections of the community.
- g) To promote, advance & encourage the members of all communities and/or weaker section or in helping, promoting, advancing & encouraging primary / secondary & Higher Education including Technical, Medical Education, Physical Training, Training of Fine Art, other useful Art- Crafts, Information Technology among the children/students of all sections of society by seeking recognition & affiliation from the Education Department of the Govt. of the state and central as well.
- h) To start various programmes against child labour & take up effective but reasonable & lawful steps in this connection for the welfare of children and destitutes in the society.
- i) To assist, render services to the women, girls, children & youth for their actual moral, social & legal rights as well as to educate the people & organize various kinds of awareness programmes for everyone i.e. Adult Education Programme, Promote literacy programmes & Integrated Rural Development Programmes of Government.
- j) To inspire & encourage Education, training in handicrafts & fine arts among the youths, Girls & Women.
- k) To open, found, establish, promote, setup, run, maintain, assist financial support and /or help in setting up colleges, lecture halls and establishment of all institutions for advancements of Education and of knowledge in arts, science, literature and all other useful subjects with all their manifestations or maintaining or running education institutions.
- l) To promote, assist or maintain all activities by whom so ever carried on or forever in India in conformity with the object of Trust as are to be the well being and general welfare of the humanity & also for their general

- b) The Financial year of the Trust will end on 30th June every year provided the Trustees shall be at liberty to change the same if they so deem fit & proper.
 - c) The Chief Trustee may whenever deem necessary, call a meeting. The notice of the meeting shall be delivered by Post to the Trustees of the Trust at least 10 day prior to the date of meeting. The notice must indicate the place, date and time thereof as well as the agenda.
 - d) No person being in the following conditions will be eligible to be the Trustee of the Trust if
 - 1) declared insolvent.
 - 2) convicted of an offence involving moral turpitude.
 - 3) of unsound mind.
 - e) A person shall cease to be a Trustee if
 - 1) he dies.
 - 2) he becomes bankrupt.
 - 3) he becomes insane or otherwise becomes incapable to act.
 - 4) he resigns his office voluntarily.
- 10) The Chief Trustee will be the absolute in charge of the Trust and will exercise all the Discretionary and sovereign powers. The Chief Trustee will also have absolute power to deal with all financial matter, Bank Accounts and all money transactions of the Trust.
 - 11) It is hereby declared that no part of the Trust property or its income shall be applied for any purpose other than the objects of the Trust as understood under the Income Tax Act, for the time being in force and the surplus funds if any of the Trust shall be invested as per the provision of the Indian Trust Act.
 - 12) The number of the Trustees shall not be less than five and not more than eleven. The Trustees shall be Trustees for their life time but any Trustee may resign by giving in writing to the Co-Trustees. Appointment of the Trustee(s) shall be only with the final approval of Chief Trustee/his Nominee(s) or the Successor(s).
 - 13) The General Management and control of the Trust properties and its affairs shall be vested in the Chief Trustee and he shall have power to do all such acts as may be considered necessary for the benefit of the Trust and/or management of its properties and affairs. Veto power shall always remain with Chief Trustee, his Nominee or the Successor(s)
 - 14) Without prejudice to any of the powers that the Trustee may have under any law for the time being in force or to their general powers for management, the Trustees shall have the following powers.
 - a) To manage the Trust, the Trust fund, Trust property and other affairs relating to the Trust and to do all acts, deeds and things necessary for the preservation, maintenance and management thereof and the affairs relating thereto or connected therewith including the making of Rules and Regulations from time to time.
 - b) To apply any part of the Trust fund in acquiring moveable /immovable properties and sell, mortgage, alienate or otherwise dispose of the same as they may think fit and proper.
 - c) To take on rent or lease, purchase or construct building and to construct, add alter demolish, maintain, sell dispose or alienate or otherwise deal with any property moveable or immoveable comprising the Trust Fund for the achievement of the objects of the Trust.
 - d) To acquire, purchase change, transpose or otherwise deal with all or any of the investments including shares, stocks, debentures, Govt. Securities belonging to the Trust or representing the Trust fund and to re-invest the same as the Chief Trustee may deem.
 - e) it and proper in accordance with the provisions of income tax Act.
 - f) To apply and get registered under sec.80-G of the Income Tax Act.

- g) To accept donations contributions, gifts and/or other grant in aid either in money or in kind.
 - h) To enter into any contract and borrow money for the purpose of the Trust and Management of its properties and assets.
 - i) To open account(s) and give direction of transfer, endorse and sign government securities, promissory notes, shares, debentures, securities, instruments etc and all these accounts shall be operated by the Chief Trustee generally as decided by him but the decision of the Chief Trustee/Nominee(s) or the Successor(s) shall be final.
 - j) To appoint Sub-Committees comprising one Trustee or more for carrying out the objects and purposes of the Trust or matters connected with the Trust and/or its affairs.
 - k) To institute suits, actions and legal proceedings to prefer appeals to make applications or petitions and to give affidavits, wherever necessary and to defend or compound, compromise, abandon submit to arbitrations or otherwise settle any suit, actions, claims, legal proceedings, appeal, demand or dispute relating to the Trust matters.
 - l) To keep proper accounts of the trust fund and its property.
 - m) To apply to whole or any part of the Trust Fund (Corpus and / or income) or property for the objects and purposes of the Trust and to set apart the whole or part of the income of the Corpus or part thereof for any of the objects of the trust.
 - n) To amalgamate the Trust with other institutions associations, Trust or organization having public charitable objects of similar nature and purposes with the consent of two third of Trustees in writing.
 - o) To nominate, appoint and constitute attorney(s), Legal practitioners, agents etc and to delegate the duties and powers vested in them (Trustees) with regard to the management of the Trust Property including starting or defending of legal proceedings or for opening or operating upon such accounts with any Bank(s), person(s), Firm(s) or to do such other acts and duties relating to or connected with the Trust property as may be deemed necessary.
 - p) To appoint/nominate patrons and to give such other designations to various persons extending help for the running or for the cause of the Trust.
 - q) And generally to do all acts, deeds and things as may be necessary for administration of the Trust.
 - r) The Trustees will not be entitled to receive remunerations as Trustees but may reimburse themselves of all expenses actually incurred by them in connection with Trust or their duties thereto.
- 15) The Trustees may from time to time, frame Rules for the conduct of the administration of the Trust and regulating the meeting of Trustees. In the absence of such regulations:
- a) All the matters will be decided by the majority and the quorum for the meeting shall be two third.
 - b) A resolution circulated to all the Trustees and signed by the Majority of such Trustees shall be as valid and effectual as resolution duly passed at a meeting of the Trustees.
- 16) That regular account will be maintained relating to all receipts, payment, income expenditure or any property or liabilities relating to the Trust. Further the accounts of the Trust will be audited by a qualified Auditor.
- 17) The expression Trustees, Chief Trustee in this deed shall mean an include the Trustees, Chief Trustee for the time being and from time to time, the survivor or survivors of them and their heirs, executors, administrators and the last survivor of them.
